To Whom it May Concern:

I write to provide a positive recommendation for Craig Womack, whom I have known personally and professionally for many years.

I first began working with Craig in 2002. At that time, he had just joined Interactive Health, LLC (now Human Touch, LLC) as the Chief Executive Officer. My role was outside counsel on intellectual property matters.

I have dealt with many executives over the years, each of whom held various degrees of sophistication with respect to issues involving intellectual property and its role as a company asset.

It was clear from the very beginning that Craig understood the importance of properly protecting the company's intellectual property and that he was dedicated to doing so in a reasonable, efficient and cost effective manner. I worked directly with Craig on every patent application and every trademark and trade dress issue that confronted the company. While others in the product design and engineering divisions at Human Touch were instrumental in creating and developing products and new technologies, Craig had the responsibility of the final sign off on all intellectual property issues.

I witnessed first hand Craig's ability to handle complex challenges, guide a rapidly growing company, and build and maintain an energized corporate atmosphere. The trials were held in August of 2008, after Craig had left his role as CEO at Human Touch. Valuing his ability and communication skills, Craig was assigned as the company representative for Human Touch throughout the four-week court process. His presence in the courtroom and his testimony were important to Human Touch's case and helped secure multi-million dollar verdicts
